All are aware that a State Level Monitoring Committee on Shelter for Urban Homeless programme has been constituted for reviewing exclusively the programme of Shelter for Urban Homeless in Andhra Pradesh, and the said Committee has been vigorously reviewing the progress of the SUH programme (Minutes copies enclosed). During its' meetings, the Committee felt that if the payments to the NGOs and Shelter Staff are regular, the programme of SUH will run smoothly, and desired that all the pending dues to the NGOs / Shelter staff shall be cleared at once immediately. Further, in the 4th meeting of the SLMC held on 30-10-2018, it has been assured to the Committee that all the pending dues up to October 2018 will be cleared by end of November 2018. Therefore, all the Commissioners of Urban Local Bodies, where SUH are existing, and the Project Directors of MEPMA are requested to take immediate action to clear off all the dues pending to the NGOs and report compliance.

2. Further, in the reference 3rd cited, Government have requested certain Commissioners of Urban Local Bodies to take necessary action in the SUHs existed in their ULBs, as per the observations made by the Committee during their random visits and report compliance immediately (copy enclosed). As no reports are received either from the Commissioners or from the Project Director of MEPMA, it is requested once again that the Municipal Commissioners and Project Director of MEPMA concerned to take immediate action and submit their compliance immediately.

3. Further, the SLMC has desired the information pertains to the functioning of the Committees formed under the programme. Therefore, all the Commissioners of ULBs and Project Directors of MEPMA are requested to furnish the information in the prescribed proforma enclosed to this Circular within a week's time, so as to appraise the SLMC during its next meeting.

4. Therefore, it is once again requested to take immediate action on top priority on the above points and report compliances immediately.
