The Employment through Skills Training & Placement (EST&P) is one of the components of NULM and is being implemented in 32 NULM towns. The same training programme is also being implemented in non-NULM ULBs. The beneficiaries under EST&P are being trained in the courses listed under MES of MoLE for SDI scheme. It is to inform that as per circular guidelines issued by MoHUPA vide reference 1<sup>st</sup> cited, assessment and certification for the trained candidates under EST&P is being taken up through RDAT Hyderabad for assessing on the competencies prescribed in NCVT approved modules as direct candidates and successful trained candidates will be issued NCVT certificates. In the PAC, all the members have suggested that the training centers established by STPs under EST&P may be inspected by the Principals of Govt. I.T.I.s to declare those centers as testing centers for conducting assessment for the trained candidates under the programme.

In view of the above, the Commissioner, Employment & Training Department, Hyderabad is requested to instruct all the Principals of Govt. I.T.I.s in the State to inspect the training centers established by the STPs in their respective jurisdictions in coordination with the Project Director, MEPMA concerned.
