At the outset Mission Director, MEPMA reviewed on EST&P programme with EST&P team and MIS team at Mission Director Camp Office, Vijayawada on 17-12-2016 progress for the year 2014-15, 2015-16 and 2016-17 trained and placed in self-employment and wage employment to allot the targets and achievement. The MD, MEPMA expressed his displeasure with STPs who have not started the trainings even after giving ample time and instructed to start the trainings in the assigned courses on or before 30-12-2016 in 3rd PAC, otherwise the Project Directors are requested to cancel the targets allotted to the concerned under intimation to MEPMA Head Office. Also ACTION will be taken to terminate the agreement and the same will be informed to NSDC, NSDA, Govt. of India, Ministry of Skill development and entrepreneurship, Ministry of RD and Urban development and other departments. The Mission Director MEPMA has taken some decision on EST&P programme for the year 2016-17:

- **Basic Sewing Machine Operator and Surface Ornamentation course:** modify payment mode in 4 installments i.e 1st Installment 30% after 15 days, 2nd Installment 20% after course completing along with course completion certificate, 3rd Installment 30% after giving the machine and completion of the geo tagging and 3rd party assessment assessment and 4th Installment 20% after 6 months.
- **Wage employment Courses** payment mode: - 1st installment 20% after 15 days, 2nd Installment 30% after course completion certificate and upload the placements, 3rd Installment 20% after 3rd party assessment assessment and placement verification and 4th Installment 30% after 6 months.
- **Re-Skilling/ Skill upgradation:** Before starting the course the Second Party shall submit documents in respect of each candidate in proof of earnings viz salary/honorarium with the signature of the beneficiary and after completion of the batch after 3 months'the Second Party shall submit documents in respect of

each candidate in proof of earnings viz salary/honorarium with the signature of the beneficiary.

- All the Project Directors should submit the proposal ULB/Town wise wage, self-employment courses and re-skilling proposal as per the local demand to submit head office on before 29-12-2016 along with collector signature.
- All the Project Directors should complete the verification of placement either self-employment or wage employment allotted after 3 days and upload in PDs login it is mandatory.
- After verification of the placement the Project Directors should pay the placement bill in all eligible batches within 7 days to the STPs for the year 2014-15 and 2015-16.
- All the Project Directors should have identified STPs who have sufficient infrastructure in computer assistant courses already empaneled for the year 2016-17 to allotted the targets for RPs training and list will be communicate to Head Office before 20-12-2016.
- All the Project Directors should identify the 1000 members for painting course in re-skilling programme.
