For Tenali Municipality, an amount of Rs.6.00 lakhs is sanctioned towards O&M Charges for the Shelter proposed, and for refurbishment of the shelter the ULB has to bear from their own funds.

For construction of new shelters the land identified should have all necessary clearances and approvals by the authorities concerned. The cost of the land acquisition is not eligible for funding under the scheme.

The maintenance of Shelters should invariably be in compliance with the operational guidelines issued by the Ministry of Housing & Urban Poverty Alleviation, Government of India (the same can be had from the web site of AP MEPMA).

The Finance Manager is requested to release the amounts mentioned against each ULB, to the Project Directors concerned through online transfer.

The Project Directors concerned are directed to release the amount to the ULBs concerned in three installments i.e., 40% in advance, 40% after receiving Utilization Certificate (UC) of first installment and 20% in last installment after receiving UC duly signed by the Municipal Commissioner concerned.
