ORDER:

Government have issued operational guidelines for implementation of the scheme of Shelter for Urban Homeless under National Urban Livelihood Mission (NULM) in the State of Andhra Pradesh vide G.O.Ms.No. 511 MA &UD (UBS) Department dated 28.12.2013. Government vide G.O.Rt. No. 135 MA&UD (UBS) Department dated 27.01.2014 constituted Standing Committee at State Level Urban Livelihood Mission (SLUM) for consideration and approval of proposals submitted under various components of NULM. Government. vide G.O.Ms.No. 210 MA&UD (UBS) Department dated 25.10.2014 constituted a State Level Committee for reviewing the implementation of the Scheme in the State.

2. In the State Level Review Meeting held on 10-08-2017 at Vijayawada it has been resolved to constitute District Level Monitoring Committee and ULB Level Task Force Committee to monitor the programme of Shelter for Homeless at various cities in the State for Urban Homeless.

3. Accordingly, Government hereby constitute (a) District Level Monitoring Committee and (b) Urban Local Body Level Task Force Committee.

DISTRICT LEVEL MONITORING COMMITTEE:

The Committee shall meet once in a month to review the Status of Shelter for Urban Homeless / approve the proposals for establishing new shelters at District level. The Committee shall encompass with the following members under the Chairmanship of the District Collector.

ULB LEVEL TASK FORCE COMMITTEE :

The Committee shall meet periodically to review status of existing Shelters for Urban Homeless / approve proposals for establishment of new shelters and to conduct inspections of the shelters. The Committee shall encompass with the following members under the Chairmanship of the Mayor / Chairman / Special Officer of the ULB concerned as the case may be.
