ORDER:-

In pursuance of the proposals submitted by the Municipal Commissioners of Kadapa, Nandyal, Greater Visakhapatnam Municipal Corporation, Guntur Municipal Corporation, Hindupur,

Dharmavaram, Ananthapur, Kakinada and Madakasira Urban Local Bodies, sanction is hereby accorded for establishment of Shelter for Urban Homeless as per the guidelines issued in Rc.No.251/SUH/2015.E dated 26.07.2016, as follows:

Whereas in the reference 12th cited, the Commissioner, GVMC has requested that there is a need for renovation of the existing old Red Cross Society building by taking up repairs, construction of bath rooms with retro fittings and paintings to the building and requested to sanction an amount of Rs. 7.90 lakhs (5.90+2.00) towards refurbishment of existing old Red Cross Society building located at Peda Valtair (17th ward), Zone-II for opening of shelter.

In view of the above, sanction is hereby accorded for establishment of Shelters in the above ULBs, as proposed by the Municipal Commissioners concerned and as restricted as per norms and to release funds as indicated in the table, and also for an amount of Rs.7.00 lakhs (Rupees Seven Lakhs only) to the GVMC for establishment of shelter at old Red Cross Society building as the O&M for the said shelter was released vide this office proceedings Roc.No. 4569/SUH/MEPMA/2013 dated 03.05.2017, with the following conditions.

- (i) Refurbishment amount will be released only after completion of the work by the contractor, and submission of UC by the Municipal Commissioner concerned.
- (ii) O & M Expenditure will be released in three installments in the ratio of 30:30:40, on receipt of UCs by the Municipal Commissioner concerned.
- (iii) The maintenance of Shelters should invariably be done in compliance with the operational guidelines issued by the Ministry of Housing & Urban Poverty Alleviation, Government of India, from time to time. (the same can be had from the web site of AP MEPMA).



The Finance Manager is requested to release an amount of Rs. 149.00 lakhs (Rupees One Crore Forty Nine Lakhs Only) to the Project Directors concerned through online transfer, and also requested to release an amount of Rs.7.00 lakhs to the Project Director, Visakhapatnam for refurbishment of the existing old Red Cross Society building located at Peda Valtair (17th ward), Zone-II, on receiving requests through AWWP.

It is strictly informed that at least 75-80% of the proposed strength of the inmates should be maintained and in any shelter if the strength of inmates is reduced drastically the shelter need to be closed by accommodating the inmates in another nearby shelter/shelters.
