All the DMCs(BL) & I/Cs Bank Linkage attended the meeting except Ananthapuram, Chittoor, Prakasam Visakhapatnam and Nellore.

SMC-BL, reviewed agenda wise and District wise Performance and resolved the following action points. The parameter wise rating was done to all DMCs as per last review meeting and informed to improve the marks in all Non Negotiables.


❖ It is resolved to take up the following **Action points** with immediate effect:

- To achieve the Double the targets set in the online before 28.02.2018, as informed earlier,
- To conduct CBRM regularly and reduce the NPA from 5.28 % to 2% and Streenidhi NPA from 10 % to 5% by 31.03.2017.
- To update the SHG Bank linkage and SEP disbursements in NULM website as per the SPARK parameters on or before 31-12-2017. PDs/PO should note that this is most important task and in case of any delay in entering the data will be viewed seriously and suitable action will be initiated against the concerned.
- **SEP** : to follow the guidelines of NULM scrupulously in selection and sanctioning of SEP borrowers & submit CO wise performance in this regard.
- Ensure uploading the SEP(I&G) applications also should be in 1:3 ratio.
- Impart EDP trainings to all borrowers and enter in to NULM web-site.
- Submit analysis report of SHG Bank Linkage analysis before 29-12-2017 in the following proforma: 1.No. of SHG in the ULB, 2.No. of dormant SHGs, 3.No. of SHGs in term loan mode, 4.No. of other SHGs availed loans, 5.No. of SHGs eligible for loans,6.Status of Rest of SHGs .
- Submit information regarding Interest Subvention & Capital Infusion on or before 23-12-2017. The information of defaulters will be placed before MD Sir for taking necessary action.
- Advised to encourage the SHG members to take up Livelihood units and avail finance under Streenidhi web based loans.
- To cross check the data entry regularly regarding to Non-data sharing Banks.

All the participants are advised to submit Action taken report by 31.12.2017.Meeting concluded with vote of Thanks by Manager (MIS).
