The Municipal Commissioner, Kavali and the Project Director, Nellore are requested to identify suitable place for construction of Tin Sheet sheds with a cost of Rs.15.00 lakhs for

accommodating the inmates.

The maintenance of Shelters should invariably be in compliance with the operational guidelines issued by the Ministry of Housing & Urban Poverty Alleviation, Government of India from time to time (the same can be had from the web site of AP MEPMA).

The Finance Manager is requested to release an amount of Rs. 15.00 lakhs to the Project Director, Nellore and an amount of Rs. 13.00 lakhs to the Project Director, Kurnool through online transfer as and when a requisition is processed through AWP after obtaining all the necessary documents.

The Project Directors concerned are directed to release funds in three installments i.e., 40% after grounding the work, 40% after receiving Utilization Certificate (UC) of first installment and 20% of last installment after receiving UC of 2nd installment, and after satisfy themselves by physical verification of the structure (SUH) in all aspects as per the requirement of Operational Guidelines of NULM, and at the time of its commencement only.
